**THE ALLEGATION:**

**That being a registered chiropractor you are guilty  
of unacceptable professional conduct**

**PARTICULARS OF THE ALLEGATION:**

That, being a registered chiropractor, you are guilty of unacceptable professional conduct in that:

On or around 23 November 2022 you:

1. Failed to maintain adequate records for Patient A as you failed to:
  - (i) Record an adequate case history for Patient A
  - (ii) Record adequate notes of Patient A's physical examination
  
2. Failed to provide an adequate standard of clinical care to Patient A, including by:
  - (i) Failing to formulate adequately, or at all, a diagnosis and/or rationale for care.
  - (ii) Failing to obtain Patient A's informed consent before commencing treatment;
  
3. You touched Patient A's buttocks by:

- (i) running your hands down her buttocks; and/or
- (ii) cupping your hands on her buttocks; and/or
- (iii) running your hands up her buttocks.

4. You failed to obtain Patient A's informed consent for your actions in particular 3(i), 3(ii) and/or 3(iii).
5. You did not have clinical justification for your actions in particular 3(i), and/or 3(ii) and/or 3(iii).
6. Your actions at particular 3(i), and/or 3(ii) and/or 3(iii) above were sexually motivated and/or inappropriate.
