The General Chiropractic Council (GCC) conducted this review of its existing Education Standards and Quality Assurance Handbook (both published in 2017), to determine whether these remain fully fit for purpose, or whether further high-level development or revisions are needed, at this time.

The ES and QA Handbook scoping review followed a process of research and consultation that was determined by the Education Standards Review Steering Group. This included mapping to standards, practice frameworks and quality assurance frameworks from other healthcare and higher education regulators, and professional and chartered bodies. Advice, feedback and opinion were also sought from key stakeholder groups through focus group interviews. These included all the current providers of approved programmes, the GCCs Education Visitors, the Royal College of Chiropractors, employers and patients and the public.

The data gathered suggests that the existing ES is broadly fit for purpose in meeting the requirements of the Code, with a key exception being that the interests of patients are currently under-represented. Following this conclusion, the Education Committee decided a full review of the Education Standards and Quality Assurance Handbook would take place in 2022.
